# Start-Up Fee Policy

Effective August 28, 2018

Registered Skeetchestn band members who are on and off reserve and all other status individuals residing on Skeetchestn Indian Band reserve may bring in their School Start-Up Fee Application to the Education Coordinator to receive a check for expenses such as school supplies and other school expenses for the student. Those status individuals not registered with Skeetchestn will have to provide a letter from their Band indicating they do not receive School Start-Up Fee's or any other type of monetary funds before Skeetchestn will consider assisting in any way

- Students in Kindergarten to grade 3 will receive \$50.
- Students in grades 4 to 7 will receive \$75.
- Students in grades 8 to 12 will receive \$100.
- Off Reserve students will be first come, first serve basis due to changing budgets each year from the Royal Trust Fund money. On-Reserve students' money will come from the Education budget.
- Extracurricular course costs may be reimbursed for students up to a maximum of \$100 per a semester. Please attach a receipt to the application

In order to be eligible for School Start-Up Fees you **MUST** have:


1. Fill out one School Start-Up Fee Application per child

3. Please provide copy of a bill with your address
4. Copy of status card
